Course Prefix/Number/Title: AH 231 Healthcare Law & Ethics

Course Description: The goal of this course is to provide the student an overview of medical law and ethics to help them understand the multiple legal and ethical issues encountered in the healthcare arena.

Course Objectives: Upon completion of this course the student should be able to :

- Describe similarities and differences between laws and ethics
- Discuss why an understanding of the legal profession is necessary for the healthcare professional
- List examples of criminal actions that relate to the healthcare worker
- Define the trial process
- Discuss conduct that may result in the loss of a license/certification for a healthcare professional
- Describe the term “standard of care”
- Describe various types of medical malpractice
- Define patients rights and patient self-determination acts
- List specific laws/obligations that pertain to healthcare professionals
- Discuss differences between licensure and certification
