Course Requirements:

Student Qualifications:

1) The student must be at least 18 years of age in order to become Nationally Registered. The student may take the EMT course and become State Certified if under 18 years of age and at least 16 at the time of testing. The State Certified EMT must become Nationally Registered after their 18th birthday.

2) If the student has been charged or convicted of a felony, prior approval must be obtained from DEMS to admit the student to class. Please contact DEMS for further information.

a. All students and ND EMS personnel must adhere to the National Registry Felony Policy in addition to DEMS policy in order to be eligible or maintain National Registry Certification. **See instructor if you have any questions or would like to read this policy.**

3) An EMS Registration form **MUST BE COMPLETED** as soon as the student begins the class. DEMS will assign a 6-digit state identification number to the student once registration is received.

4) A student must meet the physical requirements of being an EMT and be able to perform all skills required.

5) The student must be able to attend all classes as scheduled by the course coordinator.

6) The student must be able to read and write the English language and communicate effectively.

7) Any test result, cognitive or practical, is valid for a period of 12 months from the date of successful completion of the exam.

8) A candidate has 2 years from the date of course completion to complete all testing requirements. After this deadline has occurred, the candidate will be required to attend another entire course.

<u>Grading</u> is based on a standard college curve, where students earn a grade based upon the percent of total possible points they obtain. Although subject to slight modification based on the discretion of the instructor, the lecture component of this course will consist of approximately 700 points (daily participation/attendance and in class quizzes worth 250 points, 3 lecture exams worth 100 points each, and one final exam worth 150 points). Lecture points are added to laboratory points (approximately 250points) to obtain the total points possible for the course (approximately 950). (Note: Regardless of the number of points, lecture points will comprise 75% of the total points and lab points will comprise 25% of the total points.) There is a one week grace period to make up any missed exam or assignment. Any missed exam/work not made up within the allotted time will be given a zero. It is the responsibility of the student to schedule make-up work during a date and time convenient to both student and instructor. Students must maintain a minimum grade of 70.0% on coursework (not an average of 70.0%) to be able to test for national registry. Final letter grades are assigned based on the following criteria:

- A = 90.0-100% of the total points
- B = 80.0 <90.0% of the total points
- C = 70.0 <80.0% of the total points
- D = 60.0 <70.0% of the total points
- F = <60.0% of the total points
