

# Course Prefix/Number/Title: DMS 250 Comprehensive Review

Number of Credits: 3 semester credits

Course Description:

This course is designed to serve as a comprehensive review on the didactic course work of the sonography program. It is completed in the fifth semester in preparation to write the general abdominal and superficial tissue sonography examination and the obstetrical/gynecological examination of the ARDMS or the ARRT sonography examination.

- 1. Complete multiple mock examinations in general sonography to include abdomen, superficial tissue, musculoskeletal and pediatric sonography.
- 2. Complete multiple mock examinations in gynecology and obstetrics.
- 3. Complete one final test on abdominal and superficial tissue and one final test on gynecology, obstetrics within the allotted time.
