



Course Prefix/Number/Title: EC 233 Pre-K Methods and Materials

Number of Credits: 3

Course Description: This course focuses on the physical and cognitive development of children, the promotion of literacy, and the utilization of creative experiences in child care settings. Topics include developmental needs of children, age -appropriate activities, cognitive theory and brain research; creative environments, language arts, music/movement, art and aesthetic experiences. Students will evaluate, plan and implement activities that focus on children's needs and interests.

Pre-/Co-requisites: None

Course Objectives: Students will implement activities/lessons through a variety of child-directed and teacher-directed approaches. Students will recognize, select and/or create curriculum that is developmentally appropriate for the domains of cognitive, social/emotional, motor, aesthetic, physical, and language. Students will demonstrate effective teaching techniques in various curriculum areas, including: science, math, arts, music and movement, literacy, and social studies. Students will demonstrate the ability to use a variety of materials to encourage versatility of thinking and learning in children.
