

Course Prefix/Number/Title: ASC 94 – Beginning Algebra

Number of Credits: 4

Course Description:

This course helps to develop fundamental skills required for the successful completion of studies in college level mathematics courses. Topics include solving linear equations, linear graphing, exponents and polynomial operations, factoring, rational expressions and equations, and roots. Credit earned does not count towards any degree, nor does it transfer.

Placement is according to placement scores or on a voluntary basis.

Course Objectives:

It is expected that students will be able to

- Utilize problem-solving strategies to solve problems.
- Simplify expressions & solve equations.
- Plot points, graph linear equations, and find slope of a line.
- Factor using greatest common factor, factor by grouping, and factor trinomials.
- Simplify rational expressions.
- Simplify roots.

Textbook(s):

This course uses an Open Education Resource (OER) and does not require that you purchase materials to complete the work.

Course Requirements:

Learning algebra is an investment of time. Algebra is learned best by practice, reflect, and practice some more. Understanding the examples provided by the instructor and textbook is a good first step. However, to truly know the material, you should be able to look at a problem, know how to proceed, and carry out the steps WITHOUT ASSISTANCE. The independent practice and graded homework provide opportunities for you to get to that point.

**Homework (30%):** Homework will be assigned in MyMathLab at the end of each section. These are graded assignments with questions that can be done multiple times. Only the highest score will be used. These assignments close at 11:59 PM, Central Daylight Time on the due date. There will occasionally be in-class homework assignments. In-class assignments cannot be made up unless the absence is school related.

**Chapter Tests (50%):** A test will be given at the completion of each chapter. Students are allowed one attempt on each test and must be completed in one sitting. Tests must be taken on the day they are given or previous arrangements must be made prior to the test day. If you miss an exam you must contact me within 24 hours of the missed exam to arrange for a time to make up the exam. Exams must be made up within 72 hours of the original exam time. If you do not contact me within 24 hours, a grade of 0 will be entered for the exam that was missed. Students are only allowed to make up ONE exam per course. The exam grade will be docked 10% per day for late points. Make-up tests may be more difficult than the one given for the regular scheduled test.

**Final Exam (20%):** The final exam is comprehensive. Anyone who misses the final will receive a 0 on the exam and a grade of **F** for the course. No make-up final will be given. *Cheating on tests will not be tolerated. If you are caught cheating, that will result in an automatic 0 for the exam.*
