Annual Enrollment Ends on Friday, Nov 1

It's week 2 of Annual Enrollment! Employees must submit any paper applications, related to Annual Enrollment, to your organization's HR or Payroll department by Friday, November 1, 2024.

Reference the Annual Enrollment Employer Guide when processing annual enrollment benefit elections. During Annual Enrollment, NDPERS encourages employees to review their 457 Deferred Compensation (supplemental retirement savings) contributions. Keep in mind, these changes would be effective the first pay period of the following month that the election is made. This can be before 1-1-25

Other tips

- •Enrolling in the Medical or Dependent Care Flexible Spending Accounts is an ANNUAL election.
- Employees should complete their enrollments through Member Self Service (MSS).
- •Newly hired employees must complete their benefit elections for this year FIRST. Once their elections for the remainder of 2024 are completed, they can proceed with their *annual enrollment* elections for 2025.
- •The Voya Life Insurance Evidence of Insurability (EOI) form must always be printed, signed, and turned into your HR or Payroll representatives. Employees should leave Section B of the EOI blank.
- •Any paper applications including the EOI must be sent to NDPERS, at least weekly. Printed applications must be dated by the employee on or before November 1 and must be filed by the employer with NDPERS no later than Nov 8, 2024.

The BIT Process:

Form is completed and submitted by you.

Mental Health Services are notified.

Mental Health Services reaches out to the appropriate individuals to ensure that the student is safe.

Mental Health Services will reach out to other faculty members to gain more information on the

student.

Due to confidentiality, you will receive notification that the student has been reached out to; however, you will not receive any further information.

Reminder:

If you have a student that is currently feeling suicidal, please do not leave the student alone and call for assistance as needed, i.e. law enforcement.
