

2024-2025 Verification Worksheet - Dependent Student (V1)

Your 2024-25 Free Application for Federal Student Aid (FAFSA) has been selected for review in a process called "Verification". In this process, Dakota College at Bottineau will compare the information you provided on your FAFSA with the financial documents listed on the enclosed verification letter. If there are discrepancies, corrections will be made, and your financial aid offer may be adjusted.

The verification process may take SEVERAL WEEKS, and your federal financial aid cannot be disbursed until the process is complete. Therefore, we suggest that you submit all information to the address listed below <u>WITHIN 2 WEEKS</u>. Incomplete paperwork will be returned to you, thereby delaying the processing of your financial aid. Thank you for your cooperation and prompt response. Forms must be turned in 45 days before the end of fall/spring semester and 20 days before the end of summer semester.
